All concerned are hereby informed that, in accordance with the earlier notification No. Gen/2025/750 dated 11.03.2025, applications were invited for admission to the Ph.D. program for the academic session 2024–2025.

As per the provisions of revised Ph.D **Ordinance – 11** and with the prior approval of the Hon'ble Vice-Chancellor, eligible candidates (**JRF/NET/ONLY Ph.D/DET**) are hereby invited to appear for the **RAC (Research Advisory Committee) interview** to be held in the respective University Teaching Departments as per the schedule given below.

All concerned candidates are hereby instructed to strictly adhere to Clause 10(b) of **Ordinance No. 11** during the **Research Advisory Committee (RAC) interview**. The following original documents **must be produced at the time of the interview**, along with one set of **self-attested photocopies** for verification:

1. **All original mark sheets and certificates** along with one set of self-attested photocopies.
2. **Valid Identity Proof** (Aadhar Card / Voter ID / Passport / Driving License / PAN Card).
3. **Original UGC NET/GATE scorecard** (for exempted candidates) as per UGC and Ordinance 11 provisions. Also, bring any relevant **exemption-related documents**. Proof of M.Phil. and M.Phil. by entrance examination must be available for verification.
4. **Caste Certificate** (only for candidates belonging to reserved categories).
5. A **copy of the online application form** submitted for Ph.D. admission.
6. On the day of scheduled RAC (Interview), candidate shall fill up student information form, sign attendance sheet.
7. **No objection letter** (Consent Form) duly signed by supervisor and Head research center must be attached with Student Information Form along with other relevant documents such as Caste/domicile/income/PH/EWS (wherever applicable) certificates.
8. **Reservation of seats under different category shall be as per Govt. of MP rules.**
9. Candidates are advised to **read page no. 5 of Revised Ordinance 11** available at website.
10. Candidates must read carefully and abide by the clause 10(a) and 10(b) of revised Ph.D. Ordinance No.11 related to admission process of Ph.D. Program which is available on website of University.
11. Candidates are required to discuss their research interest/area through a presentation before RAC. The committee shall evaluate the research potential of the candidate, in Genuity of research and suitability of research center through direct interaction with the candidates. **Therefore, candidate should bring a short write up of Research plan (in 4-5copies)** illustrating broad area of research work to be undertaken, importance and applications. Candidates might also be asked to make a power point

presentation of Research plan. Hence, they are advised to bring a power point presentation. Candidates must bring their **own laptop and pen drive** for the presentation before the RAC committee.

12. One **self-attested set** of all the above documents must be **submitted at the research center**.
13. The **final merit list** will be prepared and published **after the RAC interview of the concerned subject**.
14. Please note that even if the candidate does not have a consent letter, (s) he must appear for the RAC interview, as the RAC may allot a Supervisor/ Co-Supervisor to the candidate as per its own discretion.
15. It may also be noted that merely having a consent letter shall not guarantee admission.

**Note:**

- The number of available research seats under each supervisor at the time of RAC may be subject to **change (increase or decrease)**.
- The decision of the **RAC Committee shall be final and binding** in all respects.
